# GRAND LODGE SCHOLARSHIP PROGRAM

Virginia Freemasons are committed to high standards of excellence and, part of this commitment is carried out by the Scholarship Fund, Grand Lodge, A.F.& A.M., of Virginia.

The Fund was created on July 6, 1978 and operates exclusively for charitable and educational purposes under Section 501(c)(3) of the Internal Revenue Code and is a Virginia Corporation licensed by the State Corporation Commission.

The purpose of the Fund is to provide scholarships, fellowships and other forms of financial assistance to deserving men and women from the Commonwealth of Virginia. Scholarship recipients receive \$4,000 total in scholarships payable at \$1,000 per year pending annual verification of good standing and acceptable grade point average.

Since it was established 46 years ago, the Scholarship Fund has sought to award 10 to 18 Scholarships per year. To date over 500+ scholarships have been awarded.

The Scholarship Board meets annually following the annual Scholarship submission deadline of March 1 to choose from among the eligible applicants the top choices and submit their names to the Grand Master recommending their approval for the \$1000.00 Scholarship for a period of four years.

When you consider the first year, second year, third year and fourth year Scholarships awarded by the Scholarship Board, a total of between \$65,000.00 and \$72,000.00 is paid out each year to Commonwealth of Virginia students enrolled in institutions of higher learning.

What is the source of funding for the Scholarship Fund, Grand Lodge, A.F. & A.M., of Virginia to be able to pay for these Scholarships?

Funding includes a combination of sources. These are public donations, the Ian M. Shipley Scholarship Fund Golf Tournament, the \$.40 per member assessment as per Masonic Law, and interest income from Scholarship Fund investments.

Therefore, Contributions via the Ian M. Shipley Scholarship Fund Golf Tournament are vital for the perpetuity of the scholarship program. These contributions make up 1/3 of the moneys awarded for scholarships every year.
